Introduction to CSR

The Ministry of Corporate Affairs, Government of India has notified in the Section 135 of the Companies Act, 2013 along with Companies (Corporate Social Responsibility Policy) Rules, 2014 "hereinafter CSR Rules" and other notifications related thereto which makes it mandatory (with effect from 1st April, 2014) for certain companies who fulfil the criteria as mentioned under Sub Section 1 of Section 135 to comply with the provisions relevant to Corporate Social Responsibility..

CSR : Section 135 of Companies Act, 2013

Applicability:

Section 135 applies to companies with:

Net worth of ₹500 crore or more, or

Turnover of ₹1,000 crore or more, or

Net profit of ₹5 crore or more during the immediately preceding financial year.: JUWI is obligated as it's Net profit crossed Rupees 5 Cr in March 2021, which mandates at least 3 years to comply this ACT

Requirements:

CSR Committee: Companies must constitute a Corporate Social Responsibility Committee of the Board, consisting of three or more directors, with at least one independent director.

CSR Policy: The Committee shall formulate and recommend to the Board a CSR Policy indicating activities to be undertaken as specified in Schedule VII.

Spending: Companies must spend, in every financial year, at least 2% of the average net profits made during the three immediately preceding financial years, on CSR activities as per their CSR Policy.

Reporting:

Companies need to disclose the composition of the CSR Committee, CSR Policy, and CSR initiatives in their annual report.

CSR : Section 135 of Companies Act, 2013

Companies (Corporate Social Responsibility Policy) Rules, 2014

CSR Activities:

The Rules specify that the CSR activities must be related to the areas or subjects specified in Schedule VII of the Companies Act, 2013, such as:

Eradicating hunger, poverty, and malnutrition.

Promoting education and employment-enhancing vocational skills

Ensuring environmental sustainability.

Contributions to the Prime Minister's National Relief Fund or any other fund set up by the Central Government.

Other matters/areas as prescribed.

Implementation:

The CSR Policy should specify the projects or programs to be undertaken, the modalities of execution, and the implementation schedules. Companies may also collaborate with other companies for undertaking projects or programs or CSR activities in such a manner that the CSR committees of the respective companies are in a position to report separately on such projects or programs.

CSR : Section 135 of Companies Act, 2013

Monitoring:

The CSR Committee should monitor the implementation of the CSR Policy and report its findings to the Board, which should then report to the shareholders.

Note:

The companies are allowed to implement their CSR activities through a registered trust, a registered society, or a company established under Section 8 of the Companies Act, 2013, or alternatively through an implementing agency.

JUWI : formed JUWI SPANDANA TRUST for CSR Activity.

Compliance:

Failure to spend the required amount does not result in any penalty, but companies must disclose the reasons for not spending the amount in their annual report. Non-disclosure of the CSR report and non-compliance with CSR provisions can lead to penalties.




